### Highlights of the period

#### Demanding comparison basis with Q1 2023

- Smaller contribution from "spot" environmental clean-up and emergency activities in France and abroad
- Lower energy sales prices in France
- Early maintenance shutdown on T1 2024 at Salaise (France)

### Solid markets in France and slight decline internationally

- French revenue: +2.9% (organic change excluding spot business, energy and maintenance shutdown at Salaise)
- International revenue: -2.0% (organic change excluding spot business)

### ■ FY 2024 revenue target confirmed: close to €1,100 million

- Reduction in unfavorable base effect related to environmental clean-up and emergency contracts from Q2 onwards
- Increased availability of DD incineration in H2 2024

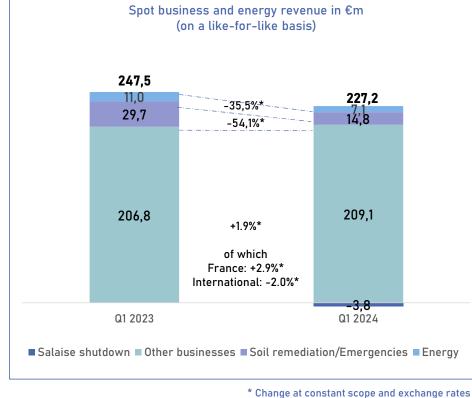
# Stable revenue at March 31, 2024 Contribution of 2023 acquisitions

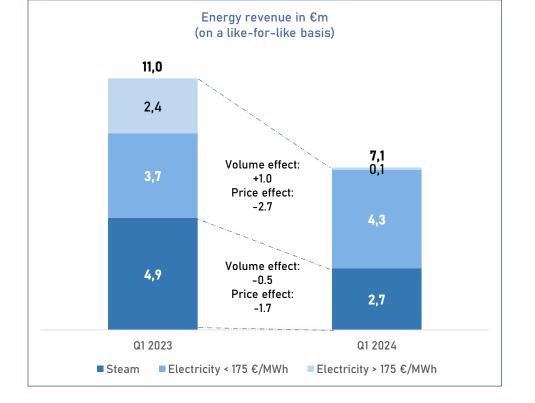

# One-off impact of spot activities and the Salaise shutdown Energy effect



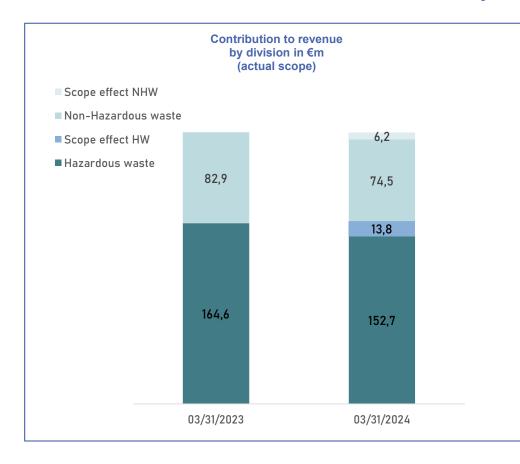


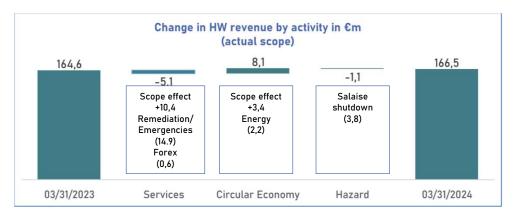

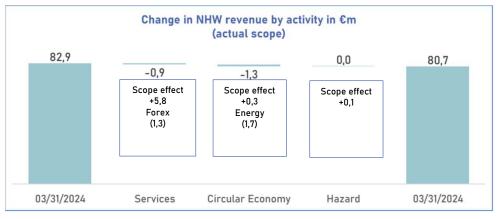

# DD division: impact of spot activities DND division: impact on Forex and Energy

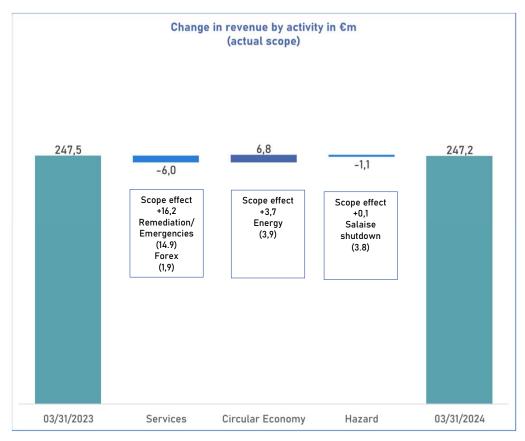


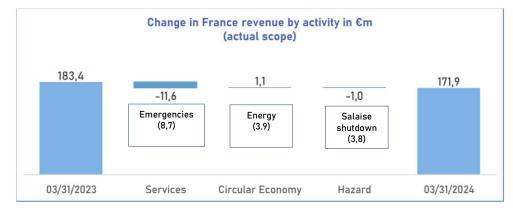

# Solid Circular Economy (excluding Energy) and Hazard Management businesses Impact of spot markets on Services



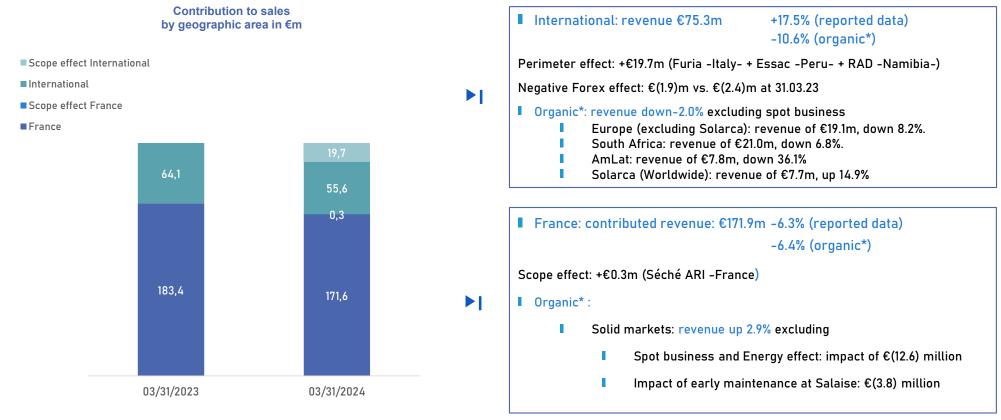

# France: Solid markets (excluding site operations and energy) International: Contribution of acquisitions

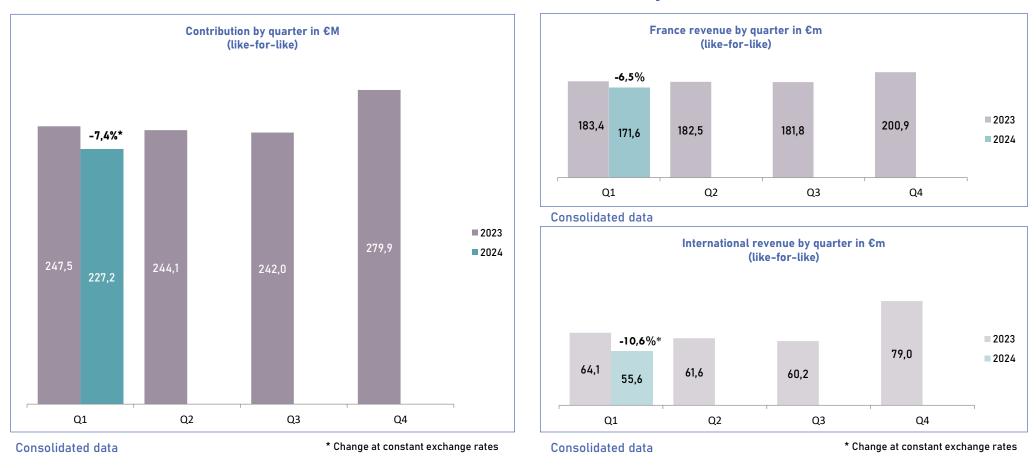

# 2024 outlook

### FY 2024 revenue targets confirmed



Solvent regeneration and chemical purification (Speichim Processing - France)

#### Return to a more normative basis of comparison as of Q2 2024

- Assumption of significantly lower energy selling prices in 2024 vs. in 2023
- Improved contribution from site operations in France and abroad
- Greater contribution from DD incineration on S2

### Annual growth target confirmed

- Organic growth: +5% on 2023\* adjusted contribution sales (€985m)
- Contribution of new perimeters: €60 million

to target sales of close to €1,100 million in 2024

\* Contribution net of price effects on energy sales and the contribution of acquisitions completed by the end of 2023 (Furia + Essac + RAD).
